#### Private List Maintenance

- When an agent adds a number to the private company do not call list:
  - DNCLcheck system updates the list instantaneously with date, time and notes created by the agent
  - Updating is instantaneous, individuals that have asked to be on the company's do not call list don't get called twice (even though there is a 30 day grace period)
- Company administrator can access the private list at any time and review and download for their own records and for also providing due diligence in the event of a complaint

#### Start-up Process

- The start-up process is extremely easy for a company
- Each company will register and have an administrator
- The administrator can add, edit and delete users with no delays
- Adding users only comprises of adding an email address, DNCLcheck emails the user who is then prompted to enter in pertinent information and complete their profile

- The administrator will be notified by email from DNCLcheck when the current Government subscription is approaching to the expiry date
